

FLAT FEE CONTRACT

All uncontested matters include filing fees, petition, waiver, final decree of divorce, 2 phone communications with staff and two emails (receipt and response for two separate emails) and one hearing.

Uncontested matters DO NOT include: service, discovery, mediation, matters involving another attorney or final trial. An uncontested matter means the parties agree on all matters, only one party has an attorney, both parties voluntarily sign all documents so that service is not required. If you start the matter as uncontested and an agreement cannot be reached, you have the option to sign a contested (hourly fee) retainer should you decide you want to have the Kutty Law Firm PLLC continue to represent you on your case or we have the right to withdraw from your case. The contested matter will require a minimum retainer to convert the case and will be billed on an hourly basis. This contract is only applicable for clients where the total value of their estate and assets are valued less than \$250,000.
